APPROVING RESOLUTION NO. 49, S-2020 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "APPROVING THE 2020 SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR CY 2020 OF THE MUNICIPAL GOVERNMENT OF BINMALEY, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 49, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Binmaley, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on March 19, 2020 by the Municipal Development Council thru Resolution No. 1, S-2020 and was favorably acted upon by the Sangguniang Bayan on March 24, 2020 thru SB Resolution No. 49, S-2020;

WHEREAS, the Supplemental Investment Program No. 1 of the municipality covers the fund augmentation for the personal services, and maintenance and other operating expenses and capital outlay of municipal offices, development projects and disaster risk reduction and management programs;

WHEREAS, the Supplemental Investment Program has an investment requirement of P35,914,527.31. Funding support for the implementation of this Supplemental Investment Program is embodied in their proposed Supplemental Budget No. 1 for CY 2020 which was approved and enacted by their Sangguniang Bayan on March 24, 2020 thru Appropriation Ordinance No. 01, S-2020;
