RESOLUTION NO. 445-2022

APPROVING RESOLUTION NO. 2021-127 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "ADOPTING THE ANNUAL INVESTMENT PLAN OF THE MUNICIPALITY OF BINALONAN FOR CALENDAR YEAR 2022"

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its SB Resolution No. 2021-127 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. In pursuance to Sections 106, 109, and 114 of the Local Government Code of 1991, the Local Development Council of Binalonan, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2022, which was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 1 Series of 2021 dated September 20, 2021;
2. The AIP of the municipality is in accordance with the Budget Operations Manual (BOM) for LGUs, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 series of 2007 dated March 8, 2007 DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. - Binalonan, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic, and other services. It likewise covers: (a) all the regular budgetary items for the operations of the different municipal offices broken down into PS, MOOE, and Capital Outlay; (b) the priority development programs/projects and those to be funded by the 20% development fund, and; (c) disaster risk reduction management programs/projects/activities of the municipality. It further includes the following: 1) Gender and Development Plan, Peace and Order Plan, Local Nutrition Action Plan, and Tourism/Cultural Development Plan, Climate Change Action Plan, Local Youth Development Plan, Annual Procurement Plan, and; 2) list of programs/projects/activities for the Local Council for Protection of Children, Senior Citizens and Persons with Disabilities, PPAs to combat Acquired Immune Deficiency Syndrome, and PPAs to address Problems on Illegal Drugs;
3. The proposed AIP has a total investment requirement of Php346,247,585.00 which will be funded from the municipality's proposed 2022 Annual Budget amounting to Php310,833,229.00 enacted on November 29, 2021 through Appropriation Ordinance No. 2021-03. The remaining amount of Php35,414,356.00 is proposed for funding from the National Government Agencies and other fund sources;
 4. The development fund amounting to Php 42,085,590.00, which is allocated for development projects and debt servicing, is equivalent to 20% of the municipality's NTA amounting to Php 210,427,949.00 for CY 2022. This is in accordance with Section 287 of RA 7160;
 5. The identified development programs/projects to be funded by the 20% of NTA are based on the DILG-DOF-DBM Joint Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);
 6. The identified programs/projects/activities to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to Php 12,261,522.00, conforms with Section 21 of RA 10121 and NDRRMC-DBM and DILG Memo Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk Reduction and Management Fund). Further, the LDRRMFI Plan 2022 of the municipality has been reviewed by the Office of Civil Defense (OCD) as per attached OCD Certification dated December 13, 2021;

7. The LGU has also identified programs/projects/activities responsive to climate change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;
8. The Gender and Development Plan of the municipality has been reviewed by the Department of the Interior and Local Government (DILG) and was found to be fully compliant in form and contents with the provisions of the Joint Memo Circular of 2016-01: Amendments to JMC 2013-01 re: Guidelines on Localization of the Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated March 19, 2021; and
9. As to the Devolution Transition Plan (2022-2024) as a supporting document of the AIP, it is respectfully recommended that the LGU should strictly observe Item No. 3.2 of DBM Local Budget Memorandum No. 82-A dated August 19, 2021 which states that “Considering the timeline on the preparation of LGU DTP under DBM-DILG JMC No. 2021-1, the LCE shall not be mandatorily required to include the LGU- DTP as part of the supporting documents of the AIP and the LEP to be submitted to the local sanggunian for budget authorization purposes. However, in case the LGU has already prepared and approved its LGU-DTP, the same may be part of the supporting documents of the AIP and LEP to be submitted by the LCE to the local sanggunian.” Further, Item 6.3.2 of the DBM-DILG Joint Memorandum Circular No. 2021-1 dated August 11, 2021 advised LGUs to “integrate fully assumed responsibilities in the updating of their local development plans, sectoral thematic plans, and investment programs”.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Binalonan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2021-127 of the Sangguniang Bayan of Binalonan, Pangasinan, entitled “Adopting the Annual Investment Plan of the Municipality of Binalonan for Calendar Year 2022”;






