PROVINCIAL RESOLUTION NO. 452-2021

**APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM
NO. 3 OF THE PROVINCE OF PANGASINAN FOR CALENDAR
YEAR 2021**

WHEREAS, presented for consideration is the Supplemental Investment Program No. 3 of the Province of Pangasinan as endorsed by the Provincial Development Council through PDC Execom Resolution No. 08-21;

WHEREAS, Supplemental Investment Program No. 3 contains other priority programs, projects and activities that are not included in the approved 2021 Annual/Supplemental Investment Programs of the Province of Pangasinan;

WHEREAS, this Supplemental Investment Program embodies fund augmentation to the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some provincial offices, and implementation of development projects and disaster risk reduction programs which are proposed to be funded from the reversion of current and continuing appropriations and outstanding payables and additional estimated income of the Province;

WHEREAS, also included are the proposed reprogramming of Department of Energy – Energy Regulations 1-94 projects from Supplemental Investment Program No. 2 CY 2021 due to changes in the Annual Work Program and the reprogramming of Local Government Support Fund-Disaster Rehabilitation and Reconstruction Program (DLGSF-DRRAP) funded project from Supplemental Investment Program No. 1 CY 2021 from “Purchase of Vaccines” to “Construction of Multi-Purpose Building/Evacuation Center” and “Rehabilitation Assistance to the Agri-Fishery Sector affected by Calamities in Pangasinan”;

WHEREAS, the said Supplemental Investment Program also encompasses the “Construction of Public Park at Barangay Libsong East, Lingayen, Pangasinan”, which is enrolled for funding from the Local Government Support Fund-Financial Assistance (LGSF-FA) to Local Government Units in Republic Act No. 11518 or the 2021 General Appropriations Act (GAA) and the “Procurement of Response Equipment/Vehicles and Other DRRM Equipment (Customized Rescue Truck and Rescue Vehicle)” to be funded from the Financial Assistance to LGUs charged against the National Disaster Risk Reduction and Management Fund under the FY 2020 GAA, Republic Act No. 11466;

WHEREAS, considered also in this Supplemental Investment Program is the revised Annual Investment Program CY 2021 of the Internal Audit Division to accommodate changes in the programs, projects and activities but with no changes in the financial requirement as well as the additional infrastructure projects funded from the 20% Development Fund and Non-Office Expenditures CY 2021;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;

WHEREAS, after careful study of the said Program, this august Body finds it to be in order;

NOW, THEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan of Pangasinan to approve, as it is hereby approved, the Supplemental Investment Program No. 3 of the Province of Pangasinan for Calendar Year 2021;

RESOLVED, FINALLY, that copies of this resolution be furnished to the Department of Budget and Management thru the Provincial Budget Officer and all authorities concerned, for their information and guidance.
