APPROVING THE INCLUSION OF THE CONSTRUCTION OF PUBLIC PARK AT BARANGAY LIBSONG EAST, LINGAYEN, PANGASINAN IN THE PROVINCIAL DEVELOPMENT INVESTMENT PROGRAM 2018-2027 OF THE PROVINCE OF PANGASINAN

WHEREAS, presented for consideration by the Sangguniang Panlalawigan is the inclusion of the Construction of Public Park at Barangay Libsong East, Lingayen, Pangasinan in the Provincial Development Investment Program 2018-2027 of the Province of Pangasinan as indorsed by the Provincial Development Council through PDC Execom Resolution No. 09-21;

WHEREAS, the PDIP is a financing plan and investment schedule during a 10-year planning period, which ensures that limited resources of the Province are allocated and utilized properly for the implementation of priority programs and projects geared towards achieving local and national roads, objectives and priorities;

WHEREAS, there is a need to update the program to include the Construction of Public Park at Barangay Libsong East, Lingayen, Pangasinan;

WHEREAS, the said project is proposed for funding by the Local Government Support Fund- Financial Assistance (LGSF-FA) to Local Government Units in Republic Act No. 11518 or the 2021 General Appropriations Act;

WHEREAS, the project has an area of 16,101 square meters and a total project cost of P30,000,000.00;
