RESOLUTION NO. 456-2021

DECLARING MUNICIPAL ORDINANCE NO. 2021-01 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED “AN ORDINANCE MANDATING THE WEARING OF BOTH FACE SHIELD AND MASK WHILE IN PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF AGNO, PANGASINAN FOR COVID-19 MITIGATION, AND IMPOSING PENALTIES FOR VIOLATION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Municipal Ordinance No. 2021-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 447 (a) (1) (iii) and (5) (xii) of RA 7160; DILG Memorandum Circular No. 2020-071 (Mandatory Wearing of Face Masks or Other Protective Equipment in Public); Memorandum Circular No. 2020-014 of the Department of Transportation; Provincial Ordinance No. 242-2020; and the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with Amendments as of April 3, 2020;


