**RESOLUTION NO. 456-2022**

**DECLARING MUNICIPAL ORDINANCE NO. 01-2022 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED “AN ORDINANCE ADOPTING THE MODIFIED OFFICIAL SEAL OF THE MUNICIPALITY OF ANDA, PANGASINAN AND PRESCRIBING THE USE AND IMPOSING PENALTY FOR UNOFFICIAL/UNAUTHORIZED USE THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Anda, Pangasinan submitted its Ordinance No. 01-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section (22) (a) (3) (b) of R. A. No. 7160 and Section 2, Chapter IV of RA No. 8491 otherwise known as “An Act Prescribing the Code of the National Flag, Anthem, Motto, Coat-Of-Arms and other Heraldic Items and Devices of the Philippines” and Sections 5, 49, 50 (a) and (b), 51 of the Implementing Rules and Regulations of RA No. 8491;

**WHEREAS**, however, the Sanggunian is advised to file the new seal or Logo of the LGU with the NHI and register the same with the DILG;

**WHEREAS**, subject ordinance shall take effect after compliance with the requirement of posting and publication pursuant to Sections 59 (c) and 511 (a) of R.A. 7160;




