APPROVING RESOLUTION NO. 04-21-17 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED "APPROVING/ADOPTING THE SUPPLEMENTAL INVESTMENT PROGRAM 2 (SIP 2) SERIES OF 2021 OF THE LGU MABINI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its Resolution No. 04-21-17 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of Republic Act No. 7160;

WHEREAS, the Local Development Council of Dasol, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2021 which was endorsed to the Sangguniang Bayan for approval on March 29, 2021 by the Municipal Development Council through MDC Executive Committee Resolution No. 02, Series of 2021;

WHEREAS, the Supplemental Investment Program No. 1 for CY 2021 covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses of some municipal offices and implementation of disaster risk reduction and other development programs/projects of the municipality;




