**RESOLUTION NO. 459-2019**

**APPROVING RESOLUTION NO. 2019-67 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "AMENDING SUPPLEMENTAL INVESTMENT PLAN NO. 2018-10 OF THE MUNICIPALITY OF BINALONAN, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Resolution No. 2019-67 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Binalonan, Pangasinan thru MDC Executive Committee Resolution No. 10, S-2018, dated November 14, 2018, endorsed to the Sangguniang Bayan the adoption of Supplemental Investment Program No. 2018-10 amounting to P80,000,000.00 to be funded by their LBP Loan proceeds (second drawdown). The Sangguniang Bayan approved said Supplemental Investment Plan No. 2018-10 thru Resolution No. 2018-211;

**WHEREAS**, the Municipal Development Council amended on February 19, 2019 the Supplemental Investment Plan No. 2018-10 because only P66,000,000.00 can be provided by the LBP (second drawdown) and the listed programs/projects are not consistent with the Municipal Ordinance No. 2018-02. This was endorsed to the Sangguniang Bayan for adoption thru MDC Executive Resolution No. 1, S-2019;

**WHEREAS**, the Sangguniang Bayan has approved the amended Supplemental Investment Plan No. 2018-10 thru Resolution No. 2019-67 dated February 20, 2019;

**WHEREAS**, the Municipal Development Council endorsed on March 27, 2019 the Supplemental Investment Plan No. 2019-01 thru MDC Executive Committee Resolution No. 2, S-2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved the Supplemental Investment Plan No. 2019-01 thru Resolution No. 2019-82 dated March 28, 2019. The Supplemental Investment Plan No. 2019-01 covers the debt servicing for the purchase of one (1) unit service vehicle in the amount of P300,000.00;

**WHEREAS**, to support the implementation of programs/projects embodied in the Amended Supplemental Investment Program No. 2018-10 amounting to P66,000,000.00 and Supplemental Investment Program No. 2019-01 in the amount of P300,000.00, the Sangguniang Bayan enacted Supplemental Budget No. 1 involving total appropriation of P66,300,000.00 thru Appropriation Ordinance No. 2019-01 dated March 28, 2019;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
