APPROVING RESOLUTION NO. 98, S-2020 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "APPROVING THE 2020 SUPPLEMENTAL INVESTMENT PROGRAM NO. 4 FOR CY 2020 OF THE MUNICIPAL GOVERNMENT OF BINMALEY, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 98, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Binmaley, Pangasinan had identified items in their Supplemental Investment Program No. 4 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on May 4, 2020 by the MDC thru Executive Committee Resolution No. 4, S-2020 and was favorably acted upon by the Sangguniang Bayan on May 5, 2020 thru SB Resolution No. 98, S-2020;

WHEREAS, the Supplemental Investment Program No. 4 of the municipality covers the programs, projects and activities to address the crisis brought about by the COVID-19 pandemic, which are based on Local Budget Circular No. 125 of the Department of Budget and Management dated April 7, 2020 – "Guidelines on the Release and Utilization of the Bayanihan Grant to Cities and Municipalities";
