**RESOLUTION NO. 459-2022**

**DECLARING MUNICIPAL ORDINANCE NO. 10, S-2021 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED “AN ORDINANCE CREATING VARIOUS POSITIONS IN THE MUNICIPAL GOVERNMENT OF BAYAMBANG AND DETERMINING ITS QUALIFICATIONS, POWER, DUTIES AND FUNCTIONS” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Ordinance No. 10-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76, 447 (a) (1) (viii) of R.A. No. 7160;

**WHEREAS**, Section 2 of the said Ordinance enumerates the qualifications of the said positions. However, Item No. 2, 13, 15, and 17 of same Section should be revised to conform with the Qualification Standards issued by the Civil Service Commission, as follows:
