RESOLUTION NO. 46-2021

APPROVING RESOLUTION NO. 109, S-2020 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED “APPROVING THE ANNUAL INVESTMENT PLAN/PROGRAM (AIP) (FUNDED BY THE 20% INTERNAL REVENUE ALLOTMENT AND OTHER SOURCES) OF THE MUNICIPALITY OF CALASIAO FOR THE YEAR 2021”

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 109, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out is in consonance to Sections 106, 109 and 114 of RA 7160. The Municipal Development Council of Calasiao, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for Calendar Year 2021. This was endorsed by the Local Development Council to the Sangguniang Bayan on August 19, 2020 through MDC Resolution No. 9, S-2020;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Calasiao, Pangasinan was prepared using the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operations of the different city offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority

development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction programs, projects and activities, and d) Activities in pursuance of the objectives of GAD of the LGU. Also attached to the AIP, among others, are the following: a) Programs/Projects to be funded by External Sources, b) Local Climate Change Action Plan, c) Peace and Order Plan, d) List of Programs/Projects/Activities (PPAs) for the Local Council for the Protection of Children, e) List of PPAs for Senior Citizens and Persons with Disabilities, f) List of PPAs to combat AIDS, g) Nutrition Action Plan, and h) Annual Cultural Development Plan;

WHEREAS, the AIP of Calasiao for CY 2021 has a total investment requirement of P724,098,944.00. Of this, P297,353,944.00 will be financed by the LGU (P291,771,274.00 for General Fund Proper and P5,582,670.00 for Local Economic Enterprise) as embodied in their 2021 Annual Budget, which was passed and approved by their Sangguniang Bayan through Appropriation Ordinance No. 17, S-2020 dated October 26, 2020. The remaining amount of P426,745,000.00 will be sourced from various NGAs and other external funds;

WHEREAS, said AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGU's IRA (P237,191,274.00), amounting to P47,438,254.80 is allocated for development projects;

WHEREAS, the development projects proposed to be funded by the 20% Development Fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs and projects included in the Municipal Disaster Risk Reduction and Management Investment Plan, amounting to P14,463,563.70, are in accordance to Section 21 of RA 10121 and Memorandum Circular No. 2013-1 of the NDRRMC, DBM, and DILG dated March 25, 2013 (Joint Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). The LGU's LDRRM Plan was reviewed and evaluated by the Office of Civil Defense (OCD) – Regional Office I;

WHEREAS, the LGU allocated funds from their 20% Development Fund and 5% LDRRM Fund for Covid-19 related PPAs. This is based on DBM Budget Circular No. 12 dated March 26, 2020. (Policy Guidelines on the Provision of Funds by LGUs for Programs, Projects and Activities to Address COVID-19 Situation);

WHEREAS, the Gender and Development Plan and Budget for CY 2021 of the LGU has been reviewed and approved by the Department of Interior and Local Government (DILG) Provincial Office, and were found to be fully compliant in form and content with the provisions of the DBM, PCW, DILG & NEDA Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women;


