DECLARING ORDINANCE NO. 19-16 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING AND SUPPLEMENTING ORDINANCE NO. 42-08, ENTITLED “AN ORDINANCE FORMING THE CHARTER OF THE BINALATONGAN COMMUNITY COLLEGE AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Ordinance No. 19-16 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and Commission on Higher Education have conducted initial review and study on said city ordinance and found out that the same was enacted pursuant to Section 458 (a) (5) (x) of R. 


