## **RESOLUTION NO. 464-2019**

**DECLARING MUNICIPAL ORDINANCE NO. 122-060818 OF THE SANGGUNIANG BAYAN OF VILLASIS, PANGASINAN, ENTITLED “AN ORDINANCE UPDATING THE CHILD WELFARE CODE OF THE MUNICIPALITY OF VILLASIS, PROVINCE OF PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Villasis, Pangasinan submitted its Municipal Ordinance No. 122-060818 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16 and 17 (a) (iv) of RA 7160; Gender and Development Code of the Philippines; RA No. 7192 (An Act Promoting the Integration of Women as Full Partners of Men in Development and Nation Building and For Other Purposes) and RA No. 9710 (Magna Carta of Women);

**WHEREAS**, however, the Sangguniang Bayan shall observe the opinion of the Provincial Legal Officer stated in her opinion dated June 28, 2019, particularly Article IX (Special Concerns) Section 1, last paragraph, Section 2 (Control on Children’s Exposure to Video Games), Section 3 (Control on Children’s Exposure to Internet Café) and last paragraph of Section 12 (Prohibited Acts Against Children in Conflict with the Law);
