**RESOLUTION NO. 467-2022**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2021 OF DASOL, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P6,100,350.00, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Dasol, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2021 involving total appropriations of P6,100,350.00, which was enacted on December 28, 2021 through Appropriation Ordinance No. 174 and approved by the Municipal Mayor on December 31, 2021;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject Supplemental Budget was determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That appropriations for Other Personnel Benefits-SRI to all municipal officials and employees of the municipality shall be subject to the provisions of Administrative Order No. 45 dated December 24, 2021 by the Office of the President and Budget Circular No. 2021-4 dated December 28, 2021;
3. That the grant of Gratuity Pay to Contract of Service and Job Order workers in the municipal government shall be in accordance with the Administrative Order No. 46 of the Office of the President dated December 29, 2021 and Budget Circular No. 2021-5 dated December 31, 2021;
4. That all procurements to be undertaken shall be subject to the provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;
5. That the items funded out of the Local Disaster Risk reduction and Management Fund shall be in accordance with R.A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and that 30% shall be set aside as Quick Response Fund; and
6. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2021 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, series of 2007 dated 08 March.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 3 for Calendar Year 2021 of Dasol, Pangasinan;


