RESOLUTION NO. 469-2022

DECLARING MUNICIPAL ORDINANCE NO. 01-2022 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING SECTION 6 (2) (b) AND SECTION 7 (2) OF ORDINANCE NO. 02-2019 ENTITLED “AN ORDINANCE GRANTING SOCIAL PENSION TO SENIOR CITIZENS WHO ARE NOT RECEIVING SOCIAL PENSION UNDER RA 9994 AND GRANTING OF OTHER BENEFITS TO ALL REGISTERED SENIOR CITIZENS OF WHATEVER SOCIAL STATUS, RACE OR RELIGION IN THE MUNICIPALITY OF SUAL” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Ordinance No. 01-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 17 (b) (2) and 447 (a) (5) (xvi) of R. A. No. 7160 and Article XV, Section 4 of the Philippine Constitution;

WHEREAS, subject ordinance shall take effect after compliance with the requirements of publication and posting pursuant to Sections 511 (a) and 59 (c) of R.A. 7160;




