DECLARING MUNICIPAL ORDINANCE NO. 5, S-2021 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, "AN **ORDINANCE INSTITUTING ENTITLED** IMPLEMENTING THE REGISTRATION OF OWNERSHIP OF AGRICULTURAL AND FISHERIES MACHINERY **EQUIPMENT** ACCORDANCE WITH **MEMORANDUM CIRCULAR** NO. 2018-02 DEPARTMENT OF AGRICULTURE AND THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT RELATIVE TO THE NATIONAL GUIDELINES FOR THE REGISTRATION OF OWNERSHIP **OF AGRICULTURAL** AND MACHINERY AND EQUIPMENT WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BAUTISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Ordinance No. 5, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 132 and 447 (a) (3) (i) of R.A. No. 7160, Republic Act No. 10601, otherwise known as "Agricultural and Fisheries Mechanization Law";
