APPROVING RESOLUTION NO. 240, S-2020 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN FUNDED UNDER SUPPLEMENTAL BUDGET NO. 2 CY 2020 SUBSIDIZED BY THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (RA 11469) AMOUNTING TO EIGHT MILLION SEVEN HUNDRED SIXTY ONE THOUSAND SEVEN HUNDRED FORTY TWO PESOS (P8,761,742.00)"

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Resolution No. 240, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Bautista, Pangasinan has formulated, adopted and endorsed the municipality's Supplemental Investment Program No. 3 through MDC Executive Committee Resolution No. 03, S-2020 dated April 13, 2020 to the Sangguniang Bayan for approval. This was approved by the Sangguniang Bayan through Resolution No. 240, S-2020 dated April 16, 2020;

WHEREAS, the Supplemental Investment Program No. 03 of the municipality with an investment requirement amounting to P8,761,742.00 covers the programs, projects and activities to address emergency response measures to COVID-19 pandemic. This will be funded from Bayanihan Grant to Cities and Municipalities under RA No. 11469 or the Bayanihan To Heal As One;
