ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN UNDER MDC RESOLUTION NO. 1 SERIES OF 2021 TO BE FUNDED FROM THE SUPPLEMENTAL BUDGET NO. 1 CY 2021 AMOUNTING TO TWENTY FOUR MILLION PESOS (P24,000,000.00)"

WHEREAS, the Sangguniang Bayan of Baustista, Pangasinan submitted its SB Resolution No. 276, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of Republic Act No. 7160;

WHEREAS, the Local Development Council of Baustista, Pangasinan has formulated and endorsed the municipality's Supplemental Annual Investment Program through MDC Resolution No. 01, S-2021 dated March 29, 2021 to the Sangguniang Bayan for approval;

WHEREAS, the Supplemental Investment Program with an investment requirement amounting to P24,000,000.00 covers the municipality's development projects and fund augmentation for the MOOE and Capital Outlay of offices in the LGU;
