**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of Republic Act No. 7160;

**WHEREAS**, the Local Development Council of Binalonan, Pangasinan has formulated and endorsed the municipality’s Supplemental Investment Plan No. 2021-02 through MDC Executive Committee Resolution No. 2021-02 dated March 17, 2021;

**WHEREAS**, the Supplemental Investment Program Supplemental Investment Plan No. 2021-02 with an investment requirement amounting to Php3,500,000.00 covers construction of slope protection with upgrading of road at Sitio Lubas, Sta. Catalina, Binalonan, Pangasinan;


