**DECLARING MUNICIPAL ORDINANCE NO. 127, S-2022 OF THE SANGGUNIANG BAYAN OF SAN NICOLAS, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (MUNICIPAL LABOR AND EMPLOYMENT OFFICER) UNDER THE MUNICIPAL LABOR AND EMPLOYMENT OFFICE AND MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICER UNDER THE MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES OFFICE IN THE LOCAL GOVERNMENT UNIT OF SAN NICOLAS, PANGASINAN, SPECIFYING ITS QUALIFICATIONS AND FUNCTIONS AND PROVIDING APPROPRIATION THEREOF”**

**WHEREAS**, the Sangguniang Bayan of San Nicolas, Pangasinan submitted its Ordinance No. 127, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the provincial Legal Officer, Local Finance Committee of the Province and the Human Resource and Management Development Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

**WHEREAS**, however, the qualifications of the positions created should be revised to conform with the Occupational Services issued by the Civil Service Commission as follows:




