**WHEREAS**, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 167, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of the of the Local Government Code of 1991. The Local Development Council of Binmaley, Pangasinan had revised its Local Development Investment Program CYs 2018-2019. This was endorsed to the Sangguniang Bayan for approval on October 1, 2018 thru MDC Resolution No. 5, S-2018 and was favorably acted upon by the Sangguniang Bayan on October 8, 2018 thru SB Resolution No. 167, S-2018;
