**APPROVING RESOLUTION NO. 2019-177 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2019 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 03 (SAIP NO. 03) OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO ELEVEN MILLION SEVENTY THOUSAND FOUR HUNDRED SEVENTY-FIVE PESOS AND SEVENTEEN CENTAVOS (P11,070,475.17)”**

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Resolution No. 2019-177 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Alaminos City, Pangasinan had identified items in their Supplemental Investment Program No. 3 for CY 2019 with a total investment requirement of P11,070,475.17. This was endorsed to the Sangguniang Panlungsod for approval on December 6, 2019 thru CDC Executive Committee Resolution No. 02, S-2019 and was favorably acted upon by the Sangguniang Panlungsod on December 10, 2019 thru SP Resolution No. 2019-177;

**WHEREAS**, the Supplemental Investment Program No. 3 for CY 2019 of the city covers the granting of Service Recognition Incentive to city officials and employees, fund augmentation for maintenance and other operating expenses and capital outlay and disaster risk reduction programs and projects of the city;
