RESOLUTION NO. 480-2021

DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CY 2020 OF NATIVIDAD, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P3,024,919.96 INOPERATIVE IN PART

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Natividad, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2020 involving total appropriations of P 3,024,919.96 which was approved on March 23, 2021 through Appropriation Ordinance No. 1-2021;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the appropriation for the Financial Assistance to Senior Citizens, Nursing Deployment Program, BHW, CVO, DCW, LGU-Contractual is not allowed. This item was vetoed by the Mayor but the Sangguniang Bayan did not override it;
2. That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R. A. No. 7160 and Article 417 (a) of its Implementing Rules and Regulations as amended by Administrative Order No. 47 dated April 12, 1993;

3. That the grant of Service Recognition Incentive to government employees for FY 2020 shall be subject to Administrative Order No. 37 of the Office of the President dated December 18, 2020; *and*
4. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2021 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2017, dated March 8, 2007.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;
