PROVINCIAL RESOLUTION NO. 483-2022

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH CENTER FOR HEALTH DEVELOPMENT-I (DOH CHD I), FOR THE IMPLEMENTATION OF THE MEDICAL ASSISTANCE FOR INDIGENT PATIENT (MAIP) PROGRAM IN TWO (2) PROVINCIAL GOVERNMENT HOSPITALS OF THE PROVINCE OF PANGASINAN

WHEREAS, the Medical Assistance for Indigent Patient (MAIP) Program is a Department of Health program intended to provide financial support to indigent and poor patients seeking medical examination, consultation, treatment and rehabilitation and those confined in government hospitals;

WHEREAS, the Department of Health Center for Health Development-I (DOH CHD I) has chosen the Province of Pangasinan to facilitate the implementation of the Medical Assistance for Indigent Patient (MAIP) Program;

WHEREAS, the two (2) provincial government hospitals of the Province which shall implement the MAIP with a total budget amounting to P2,376,000.00 are as follows:

1	Pangasinan Provincial Hospital	P2,178,000.00
2	Lingayen District Hospital	198,000.00

WHEREAS, in regard to the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Amado I. Espino III, and the Department of Health Center for Health Development-I (DOH CHD I), represented by Dr. Paula Paz M. Sydiongco, Regional Director;

WHEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


