## **RESOLUTION NO. 484-2019**

**DECLARING MUNICIPAL ORDINANCE NO. 2019-01 OF** THE SANGGUNIANG BAYAN OF **BINALONAN**, PANGASINAN, ENTITLED "AN **ORDINANCE** INSTITUTIONALIZING THE MORAL RECOVERY (MRP) IN THE PROGRAM **MUNICIPALITY** OF **BINALONAN**, PANGASINAN" WITHIN AS THE **CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT** 

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2019-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) of RA 7160; the Preamble and Article II, Section 21 of the 1987 Philippine Constitution; Proclamation No. 62 dated September 30, 1992 and Executive Order No. 319, entitled "Institutionalizing the Moral Recovery Program (MRP) in all Government Departments, Offices, Agencies and Government-Owned and Controlled Corporations through the Establishment of Integrity Circles";

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject municipal ordinance in order;
