APPROVING RESOLUTION NO. 41, S-2020 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 1 FOR CALENDAR YEAR 2020 OF DASOL, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Dasol, Pangasinan submitted its Resolution No. 41, S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Dasol, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on April 14, 2020 by the Municipal Development Council thru MDC Resolution No. 1, S-2020 and was favorably acted upon by the Sangguniang Bayan on April 16, 2020 thru SB Resolution No. 41, S-2020;

WHEREAS, the Supplemental Investment Program No. 1 of the municipality covers the programs, projects and activities to address the crisis brought about by the COVID-19 pandemic, proposed to be funded from the Bayanihan Grant to Cities and Municipalities (BGCM) which are based on the Local Budget Circular No. 125 of the Department of Budget and Management dated April 7, 2020 – “Guidelines on the Release and Utilization of the Bayanihan Grant to Cities and Municipalities”;


