**PROVINCIAL RESOLUTION NO. 484-2021**

**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A RENEWAL OF MEMORANDUM OF UNDERSTANDING WITH THE CULTURAL CENTER OF THE PHILIPPINES FOR THE CONTINUOUS ESTABLISHMENT OF THE KAISA SA SINING (KSS) REGIONAL ART CENTER IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, Kaisa Sa Sining is a partnership program of the Cultural Center of the Philippines (CCP) with local government units in order to establish a growing network of regional art centers;

**WHEREAS**, in 2018, the CCP has identified the Province of Pangasinan as one of its partners in the implementation of the said program;

**WHEREAS**, the Sangguniang Panlalawigan has authorized then the Provincial Governor to enter into and sign a Memorandum of Understanding with the CCP and there is a need now to renew the same;

**WHEREAS**, the continuous establishment of a regional partnership between CCP and the Province of Pangasinan will eventually result to further enrich, develop and promote arts and culture in the region and the country;

**WHEREAS**, the key areas of the partnership include training and apprenticeship, touring and move-over productions, sharing of relevant cultural resource materials, access to arts and cultural information, venues and facilities; and participation in major cultural events;

**WHEREAS**, the Memorandum of Understanding shall cover a period of three (3) years from 2021-2023;



**NOW THEREFORE**, on motion of SP Member Margielou Orange D. Humilde-Verzosa, duly seconded, it was -


