DECLARING ORDINANCE NO. 111, S-2019 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING AND ADOPTING A SET OF MEASURES AND SYSTEMS TO ENSURE EFFECTIVE AND EFFICIENT IMPLEMENTATION OF THE MATERNAL NEWBORN CHILD HEALTH AND NUTRITION (MNCHN) TO IMPLEMENT MNCHN SERVICES, AND ENSURING COMMODITY SELF-RELIANCE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 111, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 17 (a), (b) (2) (iii) of RA 7160; and Administrative Order Nos. 2008-2029 and 2019-0036 of the Department of Health;

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160 are complied with by the Sangguniang Bayan;
