APPROVING RESOLUTION NO. 2021-84 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2021 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 02 (SAIP NO. 02) OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO TWENTY-TWO MILLION SEVEN HUNDRED SIXTY-SEVEN THOUSAND FIVE HUNDRED EIGHTY-SIX PESOS AND EIGHTY-THREE CENTAVOS (P22,767,586.83)"

**WHEREAS**, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its SP Resolution No. 2021-84 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of Republic Act No. 7160;

**WHEREAS**, the Local Development Council of Alaminos City, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2021. This was endorsed to the Sangguniang Panlungsod for approval on April 6, 2021 through CDC Executive Committee Resolution No. 01, S-2021;

**WHEREAS,** the Supplemental Investment Program No. 2 of the city covers fund augmentation for the Maintenance and Other Operating Expenses and Capital Outlay of some city offices and implementation of various programs, projects and activities of the city government;
