DECLARING ORDINANCE NO. 2021-08 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE CREATING ONE (1) POSITION UNDER THE EXECUTIVE DEPARTMENT AND ABOLISHING ONE (1) POSITION, UPGRADING ONE (1) POSITION AND CREATING THREE (3) POSITIONS UNDER THE LEGISLATIVE DEPARTMENT OF THE LOCAL GOVERNMENT UNIT – ALAMINOS CITY” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT


