DECLARING **ORDINANCE** NO. 125. S-2020 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN **ORDINANCE CREATING** ONE (1)POSITION OF **ADMINISTRATIVE OFFICER II UNDER THE OFFICE OF THE** MAYOR OF THE LOCAL GOVERNMENT UNIT OF BASISTA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 125, S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 76 and 447 (a) (1) (viii) of RA 7160;

WHEREAS, the salary grade allocation of the position created shall be adjusted from Salary Grade 15 to Salary Grade 11 to conform with the provisions of Memorandum Circular No. 10, S-2005 entitled "Administrative Positions in the Administrative Services Group under the General Administrative Service of the Position Classification Plan;
