RESOLUTION NO. 496-2021

APPROVING RESOLUTION NO. 29, S-2021 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 CALENDAR YEAR 2021 OF THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its SB Resolution No. 29, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Local Development Council of Mapandan, Pangasinan prepared the municipality's Supplemental Investment Plan No. 2, CY 2021 which was endorsed to the Sangguniang Bayan through MDC Resolution No. 02, S-2021 dated April 21, 2021;

WHEREAS, the Supplemental Investment Program No. 2 for CY 2021 has a total investment requirement of P4,225,413.47 which covers augmentation fund for maintenance and other operating expenses, to include office as well as non-office expenditures of the LGU;

WHEREAS, funding for the Supplemental AIP will be sourced from the savings of the LGU as embodied in their Supplemental Budget No. 2, for CY 2021, which was enacted by the Sangguniang Bayan on May 12, 2021 through Appropriation Ordinance No. 2, Series of 2021;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mapandan, Pangasinan;


