**RESOLUTION NO. 496-2022**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2022 OF SAN FABIAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P218,819.60, OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2022 involving total appropriations of P218,819.60, which was enacted on February 23, 2022 through Appropriation Ordinance No. 1, S-2022;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding source for the subject Supplemental Budget was determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
2. That the reversion of savings from Personal Services shall be in accordance with the provisions of Section 336 of RA 7160 (Use of Appropriated Funds and Savings); and

3. That the Ordinance creating the Social Welfare Aide Salary Grade 4 enumerating the qualifications, duties & responsibilities and a revised plantilla of personnel under the Municipal Social Welfare and Development Office should be submitted.


