**DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CY 2021
OF MAPANDAN, PANGASINAN INVOLVING A TOTAL
APPROPRIATION OF P4,225,413.47 OPERATIVE IN ITS
ENTIRETY**

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2021 involving total appropriations of P 4,225,413.47 which was approved on May 12, 2021 through Appropriation Ordinance No. 2, Series of 2021;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of Local Finance Committee have conducted preliminary review and study on said budget pursuant to Section 316 of the Local Government Code of 1991;

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the funding sources for the subject supplemental budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417 (a) of its Implementing Rules and Regu as amended by Administrative Order No. 47 dated April 12, 1993;




