WHEREAS, the Province of Pangasinan is saddened over the death of two (2) bodyguards of former Governor and Congressman Amado T. Espino, Jr. during an attempt to ambush him in Barangay Magtaking, San Carlos City, Pangasinan last September 11, 2019;

WHEREAS, one of the fatalities is PO3 Richard Esguerra, a close-in police security escort of former Governor and Congressman Espino, who died on the spot during the ambush;

WHEREAS, the Sangguniang Panlalawigan recognizes the valor shown by PO3 Richard Esguerra who lost his life protecting a great Pangasinan leader;


