## RESOLUTION NO. 499-2022

**APPROVING RESOLUTION NO. 22-013 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 1 FOR CALENDAR YEAR 2022 OF THE MUNICIPALITY OF LAOAC, PANGASINAN AMOUNTING TO EIGHTY FOUR MILLION NINE HUNDRED SIXTY THOUSAND FOUR HUNDRED EIGHTY SEVEN PESOS (P84,960,487.00)”**

**WHEREAS**, the Sangguniang Bayan of Laoac, Pangasinan submitted its SB Resolution No. 22-013 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Laoac, Pangasinan had identified items in their Supplemental Annual Investment Program No. 1 for CY 2022, which was endorsed to the Sangguniang Bayan for approval on January 7, 2022 through MDC Resolution No. 2022-01;

2. The Supplemental Annual Investment Program No. 1 of the municipality covers the implementation of programs/projects of the LGU proposed to be funded from the shares from the 2018 and 2019 collections of Excise Tax on Burley and Native Tobacco pursuant to RA 8240 in the amount of PhP84,960,487.00. This was embodied in Supplemental Budget No. 1 of the LGU, which was enacted through Appropriation Ordinance No. 22-002 on February 14, 2022; and
3. The identified programs/projects are consistent with Local Budget Memorandum Nos. 83 & 84, both dated November 22, 2021 (Guidelines on the Release and Utilization of the Shares of LGUs from the Collections of Excise Tax).




