**APPROVING RESOLUTION NO. 64, S-2021 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 02, CY-2021 OF THE LOCAL GOVERNMENT UNIT, DASOL, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Dasol, Pangasinan submitted its SB Resolution No. 64, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

**WHEREAS**, the Local Development Council of Dasol, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2021. This was endorsed to the Sangguniang Bayan for approval on July 22, 2021 through MDC Executive Committee Resolution No. 2, S-2021;

**WHEREAS**, the Supplemental Investment No. 2 covers fund augmentation for the Personal Services (granting additional of additional year-end bonus and Performance Enhancement Incentives to municipal officials and employees) and Maintenance and Other Operating Expenses and implementation of disaster risk reduction programs, development and other priority projects of the municipality;

**WHEREAS**, funding support for the implementation of this Supplemental Investment Program in the amount of P71,134,681.16 is embodied in their proposed Supplemental Budget No. 02, CY 2021 which was enacted by the Sangguniang Bayan through Appropriation Ordinance No. 173 on October 19, 2021 and approved by the Municipal Mayor on November 2, 2021;

**WHEREAS**, the development projects proposed to be funded by 20% development fund conform with DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1, dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for Development Projects);

**WHEREAS**, however, the Construction of Perimeter Fence at the MRF and the Construction of Sanitary Landfill (Lining) are disapproved because these projects may not be allowed to be charged to Disaster Risk Reduction Management Fund, as per review opinion of the Local Finance Committee on their Supplemental Budget No. 02, CY 2021;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Dasol, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 64, S-2021 of the Sangguniang Bayan of Dasol, Pangasinan, entitled “Approving Supplemental Annual Investment Program No. 02, CY-2021 of the Local Government Unit, Dasol, Pangasinan”;
