DECLARING ORDINANCE NO. 2019-10 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING THE SELLING AND PROMOTION OF JUNK FOODS AND SUGARY DRINKS TO PREPARATORY, ELEMENTARY AND HIGH SCHOOL STUDENTS INSIDE AND WITHIN ONE HUNDRED (100) METERS PERIMETER OF PUBLIC AND PRIVATE SCHOOLS IN ALAMINOS CITY AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2019-10 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 16 and Section 17 (b) (2) (iii) and (iv) and Section 458 (a) (1) (iii) and (xiv) of RA 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of publication and posting pursuant to Sections 59 and 511 (a) of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –


