APPROVING RESOLUTION NO. 47, S-2020 OF THE SANGGUNIANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN NO. 3 CY-2020 AMOUNTING TO FOUR MILLION THREE HUNDRED TEN THOUSAND THREE HUNDRED FIFTY PESOS (P4,310,350.00)"

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Resolution No. 47, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Mapandan, Pangasinan prepared the municipality's Supplemental Annual Investment Plan No. 3, CY 2020. This was endorsed by the Council thru MDC Resolution No. 04, Series of 2020 dated November 19, 2020 to the Sangguniang Bayan for approval;

WHEREAS, said Supplemental Annual Investment Program which has a total investment requirement of P4,310,350.00, covers augmentation fund for Personal Services, MOOE and Capital Outlay of the LGU;

WHEREAS, funding for the Supplemental Annual Investment Program will be sourced from the Savings of the LGU as embodied in their Supplemental Budget No. 3, CY 2020, and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 4, S-2020 dated December 3, 2020;
