RESOLUTION NO. 500-2020

DECLARING ORDINANCE NO. 80, S-2020 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING THE MANDATORY USE OF FACE ALL MASKS BY PERSONS WHO ARE WITHIN THE JURISDICTION OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN, DURING THE COMMUNITY QUARANTINE AND **EXTENSION THEREOF" AS WITHIN THE CONFERRED POWERS** OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 80, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii) of RA 7160; DILG Memorandum Circular No. 2020-071 (Mandatory Wearing of Face Masks or Other Protective Equipment in Public Places) and Provincial Ordinance No. 235-2020 (An Ordinance Requiring the Mandatory Wearing of Face Masks by all Persons in Public Places Within the Territorial Jurisdiction of the Province of Pangasinan During the Period of Enhanced Community Quarantine and For Any Extension Thereof;

WHEREAS, however, the Sanggunian shall consider the observations of the Provincial Legal Officer in her opinion dated May 21, 2020;

WHEREAS, subject ordinance shall take effect after the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160 are complied with by the Sangguniang Bayan;
