**APPROVING RESOLUTION NO. 22-017 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 2 FOR CALENDAR YEAR 2022 OF THE MUNICIPALITY OF LAOAC, PANGASINAN IN THE TOTAL AMOUNT OF ONE MILLION THREE HUNDRED TWENTY THREE HUNDRED EIGHT HUNDRED SIXTY SEVEN PESOS & 86/100 (P1,320,867.86)”**

**WHEREAS**, the Sangguniang Bayan of Laoac, Pangasinan submitted its SB Resolution No. 22-017 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Laoac, Pangasinan had identified items in their Supplemental Annual Investment Program No. 2 for CY 2022, which was endorsed to the Sangguniang Bayan for approval on February 28, 2022 through Resolution No. 2022-02;

2. The Supplemental Annual Investment Program No. 2, with an investment requirement amounting to PhP 1,320,867.86, covers fund augmentation for the Personal Services (full implementation of the 3<sup>rd</sup> Tranche of Modified Salary Schedule for Local Government Personnel) of all offices of the municipality; and
3. To support the full implementation of SAIP No. 2, the Sangguniang Bayan enacted Supplemental Budget No.2 on March 21, 2022 through Appropriation Ordinance No. 22-003.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Laoac, Pangasinan;


