PROVINCIAL RESOLUTION NO. 503-2019

AUTHORIZING THE GRANT OF FINANCIAL ASSISTANCE TO THE CALAMITY VICTIMS CAUSED BY SEVERE TROPICAL STORM "INENG" IN THE PROVINCE OF ILOCOS NORTE

WHEREAS, the Province of Ilocos Norte was declared under a state of calamity last August 24, 2019 after it was devastated by Tropical Storm "Ineng";

WHEREAS, the Province has suffered massive flooding causing more than a billion worth of damages to agriculture and infrastructure including the loss of two lives;

WHEREAS, the League of Provinces of the Philippines has sought the assistance of its member provinces to aid the Province of Ilocos Norte in its relief, recovery and rehabilitation efforts;

WHEREAS, the Provincial Government of Pangasinan opts to extend financial assistance in the amount of P500,000.00 to the Province of Ilocos Norte;

WHEREAS, the above-significant humanitarian endeavor of the Provincial Government of Pangasinan will greatly benefit thousands of families in the areas that were affected by the onslaught of Tropical Storm "Ineng";

WHEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as it is hereby authorized, the grant of financial assistance to the calamity victims caused by severe Tropical Storm "Ineng" in the Province of Ilocos Norte;




