#### RESOLUTION NO. 505-2020

APPROVING RESOLUTION NO. 24A-2020 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "APPROVING THE REVISED SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR CY 2020 OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Resolution No. 24A-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of San Jacinto, Pangasinan proposed for the Revised Annual Investment Program (AIP) for CY 2020. This was endorsed by the Council through MDC Resolution No. 2020-2 dated April 17, 2020 to the Sangguniang Bayan for approval;

**WHEREAS**, the Sangguniang Bayan, through Sangguniang Bayan Resolution No. 24A-2020 dated April 29, 2020, approved the MDC endorsement for a Revised AIP for CY 2020;

WHEREAS, the Revised Annual Investment Program includes new/additional projects and activities, which were meant to address the COVID-19 crisis, charged to the Trust Fund/Unexpended Balances of LDRRM Fund (CYs 2017, 2018 and 2019) of the LGU. This is based on the Local Budget Circular No. 124 dated March 26, 2020 of the Department of Budget and Management. The new/additional projects and activities amounting to P7,256,503.67 are covered in the Revised Local Disaster Risk Reduction

and Management Fund Improvement Plan (LDRRMFIP) prepared and endorsed by the Municipal Disaster Risk Reduction and Management Council – Executive Committee through MDRRMC Resolution No. 2020-03-01, S-2020 dated March 27, 2020 to the Municipal Development Council;

**WHEREAS**, the preparation of the Revised AIP is in pursuance to Sections 6.4 and 6.5 of the NDRRMC-DILG-DBM JMC No. 2013-1 dated March 25, 2013;

**WHEREAS**, the Revised AIP has a total investment requirement of P157,233,951.54 compared to the previous P149,977,447.87. The increase in funds/budgets is sourced from the Trust Fund/Unexpended Balances of LDRRM Fund of the LGU;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;

WHEREFORE, in view of the foregoing, on motion of SP Members Jeremy Agerico B. Rosario and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –
