APPROVING RESOLUTION NO. 24-2020 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR CY 2020 OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Resolution No. 24-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of San Jacinto, Pangasinan has prepared their Supplemental Annual Investment Program No. 1 for CY 2020 in response to the COVID-19 crisis. This was endorsed by the Council, through MDC Resolution No. 2020-1 dated April 17, 2020 to the Sangguniang Bayan for approval;

WHEREAS, the Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 24-2020 dated April 29, 2020;

WHEREAS, said Supplemental Annual Investment Program, which has a total investment requirement of P10,040,057.00, is intended to finance programs, projects and activities and related expenses of the LGU to boost their emergency response capacity in line with the COVID-19 pandemic;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;


