REQUESTING THE MANILA WATER PHILIPPINE VENTURES, INC. TO SUBMIT ITS WRITTEN UPDATE ON THE STATUS OF THE PROPOSED WATER SUPPLY PROJECT FOR SOME LOCAL GOVERNMENT UNITS IN THE PROVINCE OF PANGASINAN

WHEREAS, the Manila Water Philippine Ventures, Inc. has a proposed project for the Province of Pangasinan which is the construction of a bulk water system that will receive water from Agno River which will be treated and distributed to the local government units;

WHEREAS, aside from the said project, some local government units in the Province of Pangasinan has approved the entry of the Manila Water Philippine Ventures, Inc. as their service provider of water in their respective areas;


