RESOLUTION NO. 508-2022

DECLARING ORDINANCE NO. 109, S-2022 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING GENDER-BASED SEXUAL HARASSMENT IN STREETS AND PUBLIC SPACES IN THE MUNICIPALITY OF LINGAYEN, PROVINCE OF PANGASINAN, PROVIDING THE GUIDELINES IN THE IMPLEMENTATION THEREOF AND PRESCRIBING PENALTIES FOR VIOLATIONS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 109, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 17 of R. A. No. 7160;

WHEREAS, subject ordinance shall take effect after compliance with the requirement of posting and publication pursuant to Sections 59 (c) and 511 (a) of R.A. 7160;




