DECLARING MUNICIPAL ORDINANCE NO. 8, S-2018 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "AN ORDINANCE ENACTING THE TEMPORARY CLOSURE OF BOTH LANES OF 6 KILOMETERS NATIONAL ROAD STARTING FROM BARANGAY BIEC TO BARANGAY MALINDONG AND THE STREETS OF BARANGAY POBLACION FROM 2:00 O'CLOCK IN THE AFTERNOON TO 7:00 O'CLOCK IN THE EVENING OF JANUARY 31, 2019; 7:00 O'CLOCK IN THE MORNING TO 12:00 O'CLOCK NOON OF FEBRUARY 1, 2019 AND 9:00 O'CLOCK IN THE MORNING OF FEBRUARY 2, 2019 TO 4:00 O'CLOCK IN THE MORNING OF FEBRUARY 3, 2019 TO ACCOMMODATE THE RELIGIOUS PROCESSION, COMMEMORATIVE PROGRAM & CIVIC PARADE AND THE SIGAY FESTIVAL/KALUTAN ED DALAN, RESPECTIVELY, WHICH ARE ALL THE HIGHLIGHTS OF THE 429TH BINMALEY FOUNDATION ANNIVERSARY AND TOWN FIESTA CELEBRATION" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 21 (a) (c) (d) of RA 7160 and Article 43 of the Implementing Rules and Regulations of RA 7160;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject municipal ordinance in order;

WHEREFORE, in view of the foregoing, on motion of SP Members Raul P. Sison and Nestor D. Reyes and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Arth Bryan C. Celeste, duly seconded, it was –


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 8, S-2018 of the Sangguniang Bayan of **Binmaley**, Pangasinan, entitled “An Ordinance enacting the temporary closure of both lanes of 6 kilometers national road starting from Barangay Biec to Barangay Malindong and the streets of Barangay Poblacion from 2:00 o’clock in the afternoon to 7:00 o’clock in the evening of January 31, 2019; 7:00 o’clock in the morning to 12:00 o’clock noon of February 1, 2019 and 9:00 o’clock in the morning of February 2, 2019 to 4:00 o’clock in the morning of February 3, 2019 to accommodate the religious procession, commemorative program & civic parade and the Sigay Festival/Kalutan ed Dalan, respectively, which are all the highlights of the 429th Binmaley Foundation Anniversary and Town Fiesta Celebration” as within the conferred powers of the Sangguniang Bayan to enact;
