APPROVING RESOLUTION NO. 19(A)-013 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 3 FOR CALENDAR YEAR 2019 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 19(A)-013 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council-Executive Committee of San Carlos City, Pangasinan has prepared the city's Supplemental Investment Program (SIP) No. 3 for CY 2019. This was endorsed by the Council thru CDC Resolution No. 03-19 (Series of 2019) dated July 9, 2019 to the Sangguniang Panlungsod for approval. The Sangguniang Panlungsod approved said endorsement through Sangguniang Panlungsod Resolution No. 19(A)-013 dated July 15, 2019;

WHEREAS, the Supplemental Investment Program covers the "Improvement of Phase III Vegetable Section (Bagsakan) at New Public Market" of the LGU, amounting to P778,805.00. Said project is part of the details of the LGU's major program, "Repairs and Maintenance of Government Facilities", which is already included in their CY 2018 AIP, and with approved funding;
