DECLARING MUNICIPAL ORDINANCE NO. 2019-02 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED "AN ORDINANCE PRESCRIBING FEES FOR THE USE OF THE MUNICIPAL COMFORT ROOM/TOILET LOCATED AT THE ALCALA PUBLIC MARKET OF THE MUNICIPALITY OF ALCALA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Ordinance No. 2019-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;
