## **RESOLUTION NO. 513-2019**

**DECLARING MUNICIPAL ORDINANCE NO. 2019-02 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “AN ORDINANCE PRESCRIBING FEES FOR THE USE OF THE MUNICIPAL COMFORT ROOM/TOILET LOCATED AT THE ALCALA PUBLIC MARKET OF THE MUNICIPALITY OF ALCALA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**
